**IT IS BEING NOTIFIED** that by a decree dated 27<sup>th</sup> April, 2026 given by the Criminal Court – (Hon. Judge Dr Natasha Galea Sciberras LL.D.), in the case:

The Republic of Malta

Versus

**SAGE GAUCI**, 27 years, car wash attendant, son of Ersilia née Gauci, born in Pietà, Malta on the 23<sup>rd</sup> of April 1999, residing at 46, Fl 5, Triq Marsamxett, Valletta and holder of Maltese Identity Card bearing number 141699(M).

**The Court ORDERED THE CANCELLATION** and the revocation *contrario imperio* of the Freezing Order issued on the assets of **SAGE GAUCI** which order was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Josette Demicoli LL.D.) by a decree dated 31<sup>st</sup> October 2018 which was duly published in the Government Gazette of the 6<sup>th</sup> November, 2018 and declared that the said order is no longer in force.

This notice is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta and in terms of Article 22A of the Dangerous Drugs Ordinance, Chapter 101 of the Laws of Malta
