

ARB/C019/2026 – VARIATION OF A FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 30th April, 2026 given by the Criminal Court – (Hon. Judge Dr Neville Camilleri LL.D.). Compilation Number 132/2026, in the case:

The Republic of Malta

Versus

ADRIAN MUSCAT, self-employed, 42 years, son of Mario Muscat and Mary Grace Muscat nee' Borg, born in Tal-Pieta', Malta, on the, 19th February 1983, and residing at Sunset View, Triq il-Wied, L-Iklin and /or 134, April Flat 2, Triq Santa Marija, Zebbug, Malta and holder of Maltese Identity Card bearing number 129983M.

The Court AUTHORISED ADRIAN MUSCAT to pay the sum of four hundred and eighty-seven Euro and sixty-six cents (€487.66) to Elmo Insurance Limited representing the renewal of the insurance policy and road license for the vehicle mentioned in the Application dated 21st April, 2026.

This variation is being published in terms of Article 23A of the Criminal Code, Chapter 9 of the Laws of Malta, Article 5 of the Prevention of Money Laundering Act, Chapter 373 of the Laws of Malta and Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Ingrid Bianco LL.D.) on the 6th February, 2026, which was published in the Government Gazette on the 2nd March, 2026 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **Adrian Muscat**.
