

ARB/C043/2026 – SEIZING AND FREEZING ORDER

IT IS BEING NOTIFIED that by a decree dated 22nd April 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr Kevan Azzopardi LL.D.). Compilation Number 2646/2026, in the case:

The Republic of Malta

Versus

LUCA EMANUELE CORITO, 23 years, son of William Dionisios Angelos and Lianne Marie nee' Farrelly, born in Pietà, Malta, on the 26th September 2002, and residing at "138, Block 10, Flat 12, Triq iz-Zewg Mini, Isla" and holder of a Maltese Identification Document bearing number 354302L.

AND

KENNETH ZARB, 26 years, son of Raymond and Joanne nee' Formosa, born in Pietà', Malta, on the 19th November 1999, and residing at "39, Tamarisk, P/H 6, Triq il-Passju, Zurrieq" and holder of a Maltese Identification Document bearing number 400999M.

The Court is issuing a "Seizure and Freezing Order" and is seizing, in the hands of third parties, in general, all monies and movable property that are due to, pertain to, or are the property of **LUCA EMANUELE CORITO** and **KENNETH ZARB**. It also prohibits the accused from transferring or otherwise disposing of any movable or immovable property, in terms of Article 22A of the Dangerous Drug Ordinance, Chapter 101 of the Laws of Malta.

The Court is authorising that the accused may, for the duration that this Freezing Order remains in force, receive the amount of thirteen thousand, nine hundred, seventy six and twenty four cents (€13,976.24c), annually, from salary, wages, pension, and social benefits paid to the accused.

Any person who acts in contravention of the Court order mentioned in Article 22A, referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand, six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.

Il-Qorti qed tordna "Ordni ta' Qbid u Friżar" u t'issekwestra f'idejn terzi persuni b'mod ġenerali l-flejjes u l-propjetà mobbli kollha li jkunu dovuti lill **LUCA EMANUELE CORITO** and **KENNETH ZARB** jew ikunu jmissu lilhom jew ikunu propjetà tagħhom, tipprojbixxi lill l-imputati milli jittrasferixxu jew xort' oħra jiddisponu minn xi propjetà mobbli jew immobbli, ai termini tal-Artikolu 22A tal-Ordinanza Dwar il-Mediċini Perikolużi, Kapitolu 101 tal-Ligijiet ta' Malta.

Il-Qorti qed tawtorizza li l-imputati jistaw, tul iż-żmien li jkun fis-seħħ dan l-Ordni ta' Friżar, jirċievu s-somma ta' tlettax-il elf, disa' mija u sitta u sebgħin euro u erbgha u għoxrin ċenteżmu (€13,976.24c), fis-sena, minn salarju , paga, pensjoni u benefiċċji soċjali li jithallsu lill imputati.

Kull persuna li tagħmel xi haġa bi ksur tal-ordni tal-Qorti msemmi fl-Artikolu 22A, tkun haġta ta' reat u tehel meta tinstab haġta multa ta' mhux iżjed minn ħdax-il elf, sitt mija u sitta u erbghin Euro u sebgħa u tmenin ċenteżmu (€11,646.87) jew prigunerija għal żmien ta' mhux iżjed minn tmax-il xahar, jew dik il-multa u prigunerija flimkien.

Kull trasferiment ieħor jew tneħħija oħra ta' propjetà li jsiru bi ksur ta' dik l-ordni tal-Qorti jkunu nulli u ma jkollhom ebda effett fil-liġi.
