IT IS BEING NOTIFIED that by a decree dated 5th May 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr Donatella Frendo Dimech LL. D). Compilation Number 3177/2026, in the case:

CONNOR JAMES BARLOW, unemployed, 24 years, son of Ian and Lisa nee' Barlow, born in Liverpool, England, on the 21st August 2001, and without a fixed address in Malta and holder of an English passport bearing number 136091320.

The Court is issuing a “Freezing Order” and is attaching, in the hands of third parties in a general all monies and other movable property due to pertaining or belonging to **CONNOR JAMES BARLOW** and further prohibits the accused from transferring , pledging, hypothecating or otherwise disposing of any immovable or movable or removable property owned or otherwise held by the accused in terms of Article 22A of the Dangerous Drugs Ordinance.

Any person who acts in contravention of the Court order mentioned in Article 22A referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand, six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
