

**ARB/C049/2026 – SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 4<sup>th</sup> May 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature – (Magistrate Dr Monica Vella LL. D). Compilation Number 3036/2026, in the case:

The Republic of Malta

Versus

**ALEKSANDAR CRVENOV**, bartender, 35 years, son of late Jean Crvenov and Mizza Crvenov, born in Macedonia, on the 5<sup>th</sup> October 1990, and residing at “Belmonte Heights, Block J, Flat 25, Saint Ignatius Street, Sliema, Malta and bearer of Maltese residence card number 515308A.

**The Court issues** a “Seizure and Freezing Order” pendente lite under Article 23A of Chapter 9 of the Laws of Malta, Article 22A of Chapter 101 of the Laws of Malta and Article 120A subsection 2A of Chapter 31 of the Laws of Malta.

Any person who acts in contravention of the Court order mentioned in Article 23A and Article 22A and Article 120A subsection 2A, referred to above shall be guilty of an offence and shall on conviction be liable to a fine (*multa*) not exceeding eleven thousand, six hundred and forty-six Euro and eighty-seven cents (€11,646.87), or to imprisonment for a period not exceeding twelve months, or to both such fine and imprisonment.

Any transfer or other disposal of any property made in contravention of the said Court order shall be null and without effect at law.
