

## ARB/C066/2020 – VARIATION OF A FREEZING ORDER

**IT IS BEING NOTIFIED** that by a decree dated 27<sup>th</sup> April, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Leonard Caruana LL.D.). Compilation Number 686/2020, in the case:

The Republic of Malta

Versus

**PIERRE GRECH CUMBO PILLOW**, businessman, 49 years, son of Augustine and Helen née Buhagiar, born in Attard, Malta on the 24<sup>th</sup> July, 1976, and residing at Blue Harbour Shackleton, Fl A2, Ix-Xatt ta' Xbiex, Ta' Xbiex and holder of Maltese Identity Card bearing number 362376M.

AND

**The Court AUTHORISED PIERRE GRECH PILLOW** to pay the amount of €81.00 (eighty-one Euro) to Bonnici Insurance Agency Limited, representing the insurance policy, including fines and fees, of the vehicle mentioned in the court decree dated 27<sup>th</sup> April, 2026, which amount shall be deducted from the sums annually received by **PIERRE GRECH PILLOW**.

This variation is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Nadine Lia LL.D) on the 9<sup>th</sup> December, 2020, which was published in the Government Gazette on the 24<sup>th</sup> December, 2020 where the court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **PIERRE GRECH CUMBO PILLOW, Jason Vella Tabone, and PGP Trading Limited**.
