

**ARB/C097/2025 – VARIATION OF A SEIZING AND FREEZING ORDER**

**IT IS BEING NOTIFIED** that by a decree dated 24<sup>th</sup> April, 2026 given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry – (Magistrate Dr Leonard Caruana LL.D.), with Compilation Number 683/2025, in the case:

The Republic of Malta

Versus

**ALMUTREESH MUHANAD SALLAM MOHAMMED**, barber, 31 years, born in Libya, on the 29<sup>th</sup> January, 1995, and residing at Apartment 3, Depiro Point, Block C, Triq Depiro, Tas-Sliema, and holder of a Maltese Identification Document bearing number 350668A.

AND

**ALMUTREESH HAMZAH SALLAM MOHAMMED;**

**The Court ORDERED** that the Seizing and Freezing Order issued against **ALMUTREESH MUHANAD SALLAM MOHAMMED** on 10<sup>th</sup> August 2025 be limited to the global amount of €8,400 (eight thousand and four hundred Euro), which amount shall remain seized in these proceedings.

**The Court further ORDERED** that all the other property of **ALMUTREESH MUHANAD SALLAM MOHAMMED** shall no longer be considered as being subject to the said Seizing and Freezing Order

This variation is being published in terms of Article 36 of the Proceeds of Crime Act, Chapter 621 of the Laws of Malta, following a freezing order which decree was given by the Court of Magistrates (Malta) as a Court of Criminal Inquiry (Magistrate Dr Gianella Camilleri LL.D.) on the 10<sup>th</sup> August 2025 which was published in the Government Gazette on the 19<sup>th</sup> August, 2025 where the Court ordered the attachment in the hands of third parties in general of all moneys and other movable or immovable property due or pertaining or belonging to **ALMUTREESH MUHANAD SALLAM MOHAMMED** and **Almutreesh Hamzah Sallam Mohammed**.
