DKR 1/2026 – REVOKED PERPETUAL AND GENERAL INTERDICTION

IT IS BEING NOTIFIED that by a decree dated 16th February, 2023 given by the Court of Magistrates (Malta) as a Court of Criminal Judicature (Magistrate Dr. Caroline Farrugia Frendo LL.D) following an application filed by Sergio Pisani on the 04th of January 2023, Compilation number 435/2020, in the case in the names:-

Vs

SERGIO CHARLES PISANI, 46 years, born in Pieta' Malta on the 21st October 1979, residing at 162, Grand Valley, Flat 8, Valley Street, Mosta Malta and holder of Maltese Identity Card bearing number 483079(M).

The Court REVOKED the general and perpetual interdiction order given against the said **Sergio Charles Pisani** following judgement dated 06th November, 2020 by the Court of Magistrates (Malta) as a Court of Criminal Judicature and this according to Article 190 of Chapter 9 of the Laws of Malta as well as according to Article 6 of Chapter 77 of the Laws of Malta the registration of the given conviction shall be removed.
